SUR (RE-BIDDING)**


1. The **METROPOLITAN NAGA WATER DISTRICT**, through its approved Corporate Budget, intends to apply the sum of **SEVENTY SIX THOUSAND EIGHT HUNDRED FIFTY THREE PESOS AND SEVENTY SEVEN CENTAVOS (Php 76,853.77)** only, being the Approved Budget for the Contract (ABC) to payments under the contract for the **FURNISHING OF LABOR, TOOLS AND EQUIPMENT FOR THE INSTALLATION OF WATERLINE EXTENSION AT NORTHERN PART OF ZONE 1, BARANGAY MARUPIT, CAMALIGAN, CAMARINES SUR (RE-BIDDING)**, CONTRACT REFERENCE NO. **INFRA 2016-011a**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The MNWD now invites bids for the **FURNISHING OF LABOR, TOOLS AND EQUIPMENT FOR THE INSTALLATION OF WATERLINE EXTENSION AT NORTHERN PART OF ZONE 1, BARANGAY MARUPIT, CAMALIGAN, CAMARINES SUR (RE-BIDDING)**. Completion of the Works is required within **One Hundred Five (105) Calendar Days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".  
  
Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from the MNWD and inspect the Bidding Documents at the address given below starting from 8:00 AM – 12:00 NN and 1:00 PM – 5:00 PM.
5. A complete set of Bidding Documents may be acquired by interested Bidders starting on **MONDAY, OCTOBER 3 to OCTOBER 24, 2016**, from the address below and upon payment of a nonrefundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **FIVE HUNDRED (Php 500.00) only**.



6. The MNWD will hold a **Pre-Bid Conference on OCTOBER 10, 2016 at 1:30 PM** at 2<sup>nd</sup> Floor, Board Room, MNWD Building, 40 J. Miranda Avenue, Naga City which shall be open only to all interested parties who have purchased the Bidding Documents.
7. Bids must be delivered to the address below on or before **OCTOBER 24, 2016**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

**Bid Opening shall be open on OCTOBER 24, 2016; 1:30 pm** at 2<sup>nd</sup> Floor, Board Room, MNWD Building, 40 J. Miranda Avenue, Naga City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The MNWD reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
