The **METROPOLITAN NAGA WATER DISTRICT (MNWD)** through its approved Corporate Budget, intends to apply the sum of **FIVE MILLION EIGHT HUNDRED EIGHTY THREE THOUSAND ONE HUNDRED SEVENTY PESOS (Php 5,883,170.00)** only, being the Approved Budget for the Contract (ABC) to payments under the contract for the **SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF FILTRATION SYSTEM DESIGNED FOR 10 LPS FOR SAN AGUSTIN & CARANGCANG PUMPING STATION & 18 LPS FOR CANAMAN PUMPING STATION CAPACITY WITH MANUAL BACKWASH, PROJECT NO. GOODS 2018-002.** Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The MNWD now invites bids for the **SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF FILTRATION SYSTEM DESIGNED FOR 10 LPS FOR SAN AGUSTIN & CARANGCANG PUMPING STATION & 18 LPS FOR CANAMAN PUMPING STATION CAPACITY WITH MANUAL BACKWASH.** Delivery of the Goods is required within **SEVENTY (70) CALENDAR DAYS.** Bidders should have completed, within the last two (2) years, from the date of submission and receipt of bids, a contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information from the MNWD and inspect the Bidding Documents at the address given below starting from 8:00 AM - 12:00 NN and 1:00 PM - 5:00 PM.
5. A complete set of Bidding Documents may be acquired by interested Bidders starting on **THURSDAY APRIL 19 to MAY 8, 2018,** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **TEN THOUSAND PESOS (Php 10,000.00)** only.

6. The MNWD will hold a **PRE-BID CONFERENCE** on **APRIL 26, 2018 at 1:30 PM** at 2nd Floor, Board Room, MNWD Building, 40 J. Miranda Avenue, Naga City which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **MAY 8, 2018 at 1:30 PM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

BID OPENING shall be on **MAY 8, 2018 at 1:30 PM** at 2nd Floor, Board Room, MNWD Building, 40 J. Miranda Avenue, Naga City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The MNWD reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
