The BAC Chairperson read the attendance and welcomed the Committee Members in the Pre-Bid Conference for the project Furnishing of Labor and Materials for the Installation of Distribution Line at Zone 7, Sitio Soriano, Barangay San Isidro, Naga City (INFRA 2019-014) with an Approved Budget for the Contract (ABC) of **THREE HUNDRED FOURTEEN THOUSAND THREE HUNDRED SEVENTY THREE PESOS AND 46/100 (Php 314,373.46) ONLY**.
