BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD OF CONTRACT TO RONDEX ENTERPRISES CORPORATION

WHEREAS, the Metropolitan Naga Water District (MNWD) Bids and Awards Committee (BAC) through its Secretariat posted the Invitation to Bid (ITB) for the project Supply and Delivery of Various Pipes and Fittings for Leak Repairs (GOODS 2020-003) in the Philippine Government Electronic Procurement System (PhilGEPS), MNWD Website and Bulletin Board starting August 27 to September 16, 2020, with an Approved Budget for the Contract (ABC) of ONE MILLION FOUR HUNDRED EIGHT THOUSAND EIGHT HUNDRED FORTY PESOS (Php 1,408,840.00) Only, and the Delivery of goods is required within Thirty (30) Calendar Days;

WHEREAS, in response to the Invitation to Bid, there were two (2) prospective bidders who signified their intentions to participate in the scheduled bidding and thereafter procured bidding documents, namely: (1) Constech Asia Corporation; and (2) Rondex Enterprises Corporation;

WHEREAS, on the deadline for the submission of bid on September 28, 2020, 1:30 PM, the two prospective bidders submitted their bid proposals per record book (logbook) of the BAC Secretariat;


WHEREAS, during the preliminary evaluation of bids conducted last September 28, 2020, the bids of Constech Asia Corporation and Rondex Enterprises were found to be eligible;

WHEREAS, the BAC passed the resolution no. 34, series of 2020 re: to maximize the allowable period prescribed in the conduct of Post-Qualification Evaluation in consideration of the limited access to financial institutions, regulatory and other offices, as well as the implementation of government









restrictions on transport and travel due to the prevailing health crisis brought about by COVID-19 pandemic, which was duly approved by the Head of the Procuring Entity (HOPE) on September 28, 2020;

WHEREAS, upon careful examination, validation and verification of the bidder's eligibility, technical and financial requirements submitted, the bid of Rondex Enterprises Corporation was found to be Responsive and was subsequently declared by the BAC as the Lowest Calculated and Responsive Bid (LCRB) for the project Supply and Delivery of Various Pipes and Fittings for Leak Repairs (GOODS 2020-003);

NOW THEREFORE, we, the Members of the Bids and Awards Committee, hereby **RESOLVE, as it is hereby RESOLVED:**

- To declare Rondex Enterprises Corporation, as the bidder with the Lowest Calculated and Responsive Bid (LCRB) for the project Supply and Delivery of Various Pipes and Fittings for Leak Repairs (GOODS 2020-003) and subsequently award the contract amounting to ONE MILLION TWO HUNDRED SIXTY THOUSAND TWO HUNDRED FIFTY-NINE PESOS (Php 1,260,259.00) Only;
