## **RESOLUTION NO. 49**

Series of 2020

## BAC RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD OF CONTRACT TO IVANKA TRADING

WHEREAS, the Metropolitan Naga Water District (MNWD) Bids and Awards Committee (BAC) through its Secretariat posted the Invitation to Bid (ITB) for the project Supply and Delivery of Various Equipment (Brand New) for Leak Repairs (Re-Bidding) (GOODS 2020-005A) in the Philippine Government Electronic Procurement System (PhilGEPS), MNWD Website and Bulletin Board starting November 18 to December 7, 2020, with an Approved Budget for the Contract (ABC) of ONE MILLION EIGHTEEN THOUSAND SIX HUNDRED PESOS (Php 1,018,600.00) Only, and the Delivery of goods is required within Sixty (60) Calendar Days;

**WHEREAS**, the first Invitation to Bid for the project was duly posted in the PhilGEPS from October 15 to November 3, 2020;

**WHEREAS**, on the deadline for the submission of bid on November 3, 2020 1:30 PM, only one prospective bidder has submitted its bid proposal as can be clearly gleaned at the record book (logbook) of the BAC Secretariat, namely **IVANKA TRADING**;


**WHEREAS**, during the opening on November 3, 2020 of the sealed envelope containing the Technical Documents among others, the BAC duly noted that the required "**Warranty** Certificate and Certification on Services for Tools with Factory/Manufacturer's Defect" were missing;

**WHEREAS**, upon due deliberation, the BAC outright declared the bid of IVANKA TRADING as "failed", in accordance with the provision stated under Section 30.2 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184, to wit:

"Section 30.2. xxx In case any of the requirements in the second envelope of a particular bid **is missing, incomplete or patently insufficient**, and/or if the submitted total bid price exceeds the ABC, the BAC shall rate the bid concerned as "failed." Only bids that are determined to contain all the bid requirements for both components shall be rated "passed" and shall immediately be considered for evaluation and comparison."

**WHEREAS**, notwithstanding the outright declaration of ineligibility of the above said bidder, the BAC, in accordance with RA 9184 and its 2016 Revised IRR, has given the said bidder three (3) calendar days within which to file a written request for reconsideration before the BAC;

**WHEREAS**, on the same date, IVANKA TRADING thru its General Manager, Mr. John Mendoza Y. Ang, submitted their letter for reconsideration stating their apology for overlooking to include in their submitted bid the aforementioned required documents;

**WHEREAS**, last November 5, 2020, the BAC on its special meeting, convened and deliberated the request of IVANKA TRADING;

WHEREAS, upon diligent review and deliberation, the BAC unanimously decided to deny the motion for reconsideration of IVANKA TRADING, anchoring on the grounds as explicitly provided under Section 30.2 of Republic Act 9184 and its 2016 Revised IRR, and issued BAC Resolution No. 43, Series of 2020 re: declaring First Failure of Bidding for the project GOODS 2020-005: Supply and Delivery of Various Equipment (Brand New) for Leak Repairs and subsequently rescheduled a re-bidding for the same and recommending approval by the Head of Procuring Entity (HOPE);

**WHEREAS**, in response to the Invitation to Bid of re-bidding, only one (1) prospective bidder signified its intention to participate in the scheduled bidding and thereafter procured bidding documents, namely: (1) Ivanka Trading;

**WHEREAS,** on the deadline for the submission of bid on December 7, 2020, 1:30 PM, Ivanka Trading submitted its bid proposal per record book (logbook) of the BAC Secretariat;

**WHEREAS**, during the preliminary evaluation of bid conducted last December 7, 2020, the bid of Ivanka Trading was found to be eligible;


WHEREAS, the detailed evaluation of bids conducted last December 9, 2020, resulted to:

**WHEREAS**, upon careful examination, validation and verification of the bidder's technical and financial requirements submitted, the bid of Ivanka Trading was found to be Responsive and was subsequently declared by the BAC as the Single Calculated and Responsive Bid (SCRB) for the project Supply and Delivery of Various Equipment (Brand New) for Leak Repairs (Re-Bidding) (GOODS 2020-005A);

**NOW THEREFORE**, we, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:
