BAC RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD OF CONTRACT TO 1MAGITING SECURITY AGENCY CORPORATION

WHEREAS, the Metropolitan Naga Water District (MNWD) Bids and Awards Committee (BAC) through its Secretariat posted the Invitation to Bid (ITB) for the project Procurement of Security Services (GOODS 2020-008) in the Philippine Government Electronic Procurement System (PhilGEPS), MNWD Website and Bulletin Board starting November 6 to November 27, 2020, with an Approved Budget for the Contract (ABC) of THREE MILLION SEVEN HUNDRED SEVENTY-EIGHT THOUSAND FOUR HUNDRED TWENTY-TWO PESOS AND 24/100 (Php 3,778,422.24) for the first year Only, and the Delivery of goods is required within THREE (3) YEAR SERVICE AGREEMENT;


