# BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD OF CONTRACT TO JLINE INDUSTRIES, INCORPORATED

WHEREAS, the Metropolitan Naga Water District (MNWD) Bids and Awards Committee (BAC) through its Secretariat posted the Invitation to Bid (ITB) for the project Supply, Delivery, Installation, and Commissioning of Filtration System Designed for 32 LPS Capacity for Cararayan 4 Pumping Station with Manual Backwash, including the Supply of other Materials and Mobilization (GOODS 2020-009) in the Philippine Government Electronic Procurement System (PhilGEPS), MNWD Website and Bulletin Board starting November 6 to November 27, 2020, with an Approved Budget for the Contract (ABC) of SIX MILLION SEVENTY-EIGHT THOUSAND SEVEN HUNDRED FORTY PESOS (Php 6,078,740.00) Only. 



**WHEREAS**, during the preliminary evaluation of bid conducted last November 27, 2020, the bids of ESCON Enterprises and JLine Industries, Incorporated were found to be eligible;

**WHEREAS**, on the detailed evaluation of bids conducted last December 2, 2020, the BAC Secretariat/TWG noted a significant mathematical error in the computation of items as stipulated in the submitted Cost Distribution under 'for Goods Offered from within the Philippines' of **JLINE Industries**, **Incorporated**, amounting to One Hundred Forty Thousand Four Hundred Pesos (Php 140,400.00) only, to which resulted to:


