BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD OF CONTRACT TO JMLD CONSTRUCTION


WHEREAS, the Metropolitan Naga Water District (MNWD) Bids and Awards Committee (BAC) through its Secretariat posted the Invitation to Bid (ITB) for the project Furnishing of Labor and Materials for the Installation of Distribution Line at Progress Homes Phase 1 Subdivision, (Phase 2) Barangay San Vicente, Canaman, Camarines Sur (INFRA 2020-013) in the Philippine Government Electronic Procurement System (PhilGEPS), MNWD Website and Bulletin Board starting September 17 to October 6, 2020 with an Approved Budget for the Contract (ABC) of FOUR MILLION SIXTY-NINE THOUSAND SEVEN HUNDRED EIGHT PESOS AND 77/100 (Php 4,069,708.77) Only, and the Completion of Work is required within Two Hundred Twenty-Five (225) Calendar Days.

WHEREAS, in response to the Invitation to Bid, there were four (4) prospective bidder who signified their intention to participate in the scheduled bidding and thereafter procured bidding documents, namely: (1) JMLD Construction; (2) MDQR Construction and Supply; (3) Holy Child Realty and Development, Incorporated; and (4) E.R. Venzon Construction;

WHEREAS, on the deadline for the submission of bid on October 6, 2020, 1:30 PM, only three (3) bidders submitted their bid proposals, namely; (1) JMLD Construction; (2) MDQR Construction and Supply; and (3) E.R. Venzon Construction submitted their bid proposals per record book (logbook) of the BAC Secretariat;

WHEREAS, during the preliminary evaluation of bids conducted last October 6, 2020, the bid of JMLD Construction was found to be eligible. However, MDQR Construction and Supply and E.R. Venzon Construction was declared ineligible due to missing document, particularly the Constructors Performance Evaluation System (CPES) Rating Sheet as an attachment to the Single Largest Completed Contract (SLCC) submitted, duly indicated in Bid Data Sheet (BDS) ITB Clause 12.1(a)(ii), of the bidding documents;


