There being a quorum, the meeting was called to order by the BAC Chairperson, Mr. Jon Louie A. Sanchez, at exactly 2:15 PM.

BUSINESS OF THE MEETING

The BAC Chairperson requested the BAC Secretariat to read the attendance and welcomed the Committee Members and bidder's authorized representative in the Pre-Bid Conference for the project Supply, Delivery, Installation, and Commissioning of Filtration System Designed for 32 LPS Capacity for Cararayan 4 Pumping Station with Manual Backwash, including the Supply of other Materials and Mobilization (GOODS 2020-009) with an Approved Budget for the Contract (ABC) of **SIX MILLION SEVENTY-EIGHT THOUSAND SEVEN HUNDRED FORTY PESOS (Php 6,078,740.00)** Only. Delivery of goods is required within **ONE HUNDRED EIGHTY (180) CALENDAR DAYS**. He further stated that the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), MNWD Website, and Bulletin Board from November 6 to November 27, 2020. An invitation was also served to the observers, namely: Commission on Audit (COA), Metro Naga Chamber of Commerce and Industry (MNCCI), and Naga City People's Council (NCPC), however, no observers attended said scheduled Pre-Bid Conference.

The BAC Chairperson then proceeded and gave the table to Engr. Ronald G. Rada, BAC Provisional Member to discuss the technical aspects of the project. Engr. Rada then discussed all aspects of the project, Supply, Delivery, Installation, and Commissioning of Filtration System Designed for 32 LPS Capacity for Cararayan 4 Pumping Station with Manual Backwash, including the Supply of other Materials and Mobilization (GOODS 2020-009). He also emphasized that there were two (2) Supplemental/Bid Bulletin posted to modify or amend items in the Technical Specification. He instructed Mr. Deblois to secure the same to properly comply with or submit necessary requirements of MNWD, and the latter concurred.

The BAC Chairperson then asked the bidder's authorized representative if there are any further clarification they would like to clarify, Mr. Deblois said that there was none.

With no further changes or modifications in the Technical Specifications of the project, the BAC Chairperson temporarily adjourned the meeting at exactly 2:30 PM.
