There being a quorum, the meeting was called to order by the BAC Chairperson, Engr. Gilbert V. Eleazar, at exactly 1:38 PM.

### **BUSINESS OF THE MEETING**

The BAC Chairperson requested the BAC Secretariat to read the attendance and welcomed the Committee Members in the Pre-Bid Conference for the project Furnishing of Labor and Materials for the Installation of Distribution Line at Zone 1 Baras, Canaman, Camarines Sur (INFRA 2020-009) with an Approved Budget for the Contract (ABC) of **SIX HUNDRED EIGHTY-EIGHT THOUSAND NINE HUNDRED TWENTY-SEVEN PESOS AND 06/100 (Php 688,927.06)** Only. Completion of Work is required within One Hundred Fifty (150) Calendar Days. He further stated that the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), MNWD Website, and Bulletin Board from JUNE 10 to JUNE 29, 2020. An invitation was also served to the observers, namely: Commission on Audit (COA), Philippine Institute of Civil Engineers (PICE), and Naga City People's Council (NCPC), however, no observers attended said scheduled Pre-Bid Conference.

The BAC Chairperson thereafter announced to the body that no prospective bidder had purchased bid documents yet as of the date, and none will attend the scheduled Pre-Bid Conference. For the information of the body, the End-User prepared a PowerPoint Presentation to discuss in detail the project's

Technical Specifications. He added that according to Section 22.3 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, states that "the pre-bid conference shall discuss, among other things, the eligibility requirements and the technical and financial components of the contract to be bid." He reminded that the BAC must also emphasize issues that are usually the reason why bidders are deemed disqualified, and the BAC concurred. Mr. Samuel A. Amores, BAC Provisional Member, thereafter presented to the BAC the specifications of the project, including the eligibility and technical requirements. The additional documentary requirement which is the Constructors Performance Evaluation System (CPES) Rating Sheet to be submitted along with the Notice of Award and/or Notice of Proceed and Certificate of Completion and Final Acceptance issued by the owner as an attachment to the Single Largest Completed Contract (SLCC) was also emphasized in the presentation.

The BAC Chairperson then asked the End-User if there are any changes with regards to the project's technical specifications, Mr. Amores answered in the negative. With no further changes or modifications in the Technical Specifications of the project, the BAC Chairperson finally adjourned the meeting at exactly 2:00 PM.
