BUSINESS OF THE MEETING

The BAC Chairperson requested the BAC Secretariat to read the attendance and welcomed the Committee Members in the Pre-Bid Conference for the project Supply and Delivery of Materials and Furnishing of Labor for the Drilling of Sta. Lucia II, Pacol IV and Pacol V Production Wells at Brgy. Sta. Lucia, Magarao, Camarines Sur and Brgy. Pacol, Naga City (INFRA 2020-011) with an Approved Budget for the Contract (ABC) of **TEN MILLION EIGHT HUNDRED THOUSAND NINE HUNDRED TWO PESOS AND 98/100 (Php 10,800,902.98)** Only. Completion of Work is required within Three Hundred Sixty (360) Calendar Days. He further stated that the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), MNWD Website, and Bulletin Board from August 25 to September 14, 2020. An invitation was also served to the observers, namely: Commission on Audit (COA), Philippine Institute of Civil Engineers (PICE), and Naga City People's Council (NCPC), however, no observers attended said scheduled Pre-Bid Conference.

 The BAC Chairperson thereafter announced to the body that no prospective bidder had purchased bid documents yet as of the date, and none will attend the scheduled Pre-Bid Conference.

Since, the technical specifications and requirements were already presented to the body during the project's Pre-Procurement Conference last August 14, 2020, it was no longer discussed by the End-User in the meeting. With that, the BAC Chairperson then asked the End-User if there are any changes with regards to the project's technical specifications, Mr. Amores answered in the negative.

With no further changes or modifications in the Technical Specifications of the project, the BAC Chairperson temporarily adjourned the meeting at exactly 2:15 PM.
