**BAC RESOLUTION DECLARING FIRST FAILURE OF BIDDING FOR THE PROJECT SUPPLY OF LABOR AND MATERIALS FOR THE DRILLING OF PACOL IV ONE (1) TEST / PRODUCTION WELL AT ZONE 1, KM. 10, PACOL, NAGA CITY (INFRA 2023-008) AND SUBSEQUENTLY RESCHEDULED REBIDDING FOR THE SAME AND RECOMMENDING APPROVAL BY THE HEAD OF PROCURING ENTITY (HOPE)/CHAIRMAN OF THE BOARD OF DIRECTORS OF METROPOLITAN NAGA WATER DISTRICT (MNWD)**

**WHEREAS**, the Metropolitan Naga Water District (MNWD) Bids and Awards Committee (BAC), through its Secretariat, posted the Invitation to Bid (ITB) for the project Supply of Labor and Materials for the Drilling of Pacol IV One (1) Test / Production Well at Zone 1, Km. 10, Pacol, Naga City (INFRA 2023-008) in the Philippine Government Electronic Procurement System (PhilGEPS), MNWD Bulletin Board, and MNWD Website from November 28, 2023 to December 18, 2023, with an Approved Budget for the Contract (ABC) of **FIVE MILLION SIX HUNDRED SIXTY-NINE THOUSAND TWO HUNDRED NINETY-THREE PESOS AND 35/100 (P 5,669,293.35)**. Completion of the Works is required by **ONE HUNDRED TWENTY (120) CALENDAR DAYS**. A Pre-bid Conference was conducted last December 5, 2023;

**WHEREAS**, in response to the Invitation to Bid (ITB), only one (1) prospective bidder signified its intention to participate in the bidding, namely: SDSJ Builders;

**WHEREAS**, during the Pre-Bid Conference last December 5, 2023, although no prospective bidder attended, the BAC noted four (4) contractors who viewed the ITB on the PhilGEPS website per Document Request List (DRL), namely: (1) LJDB Construction; (2) Pacers Trading and Services; (3) SDSJ Builders; and (4) Drill Mechanics Incorporated.

**WHEREAS**, the BAC Technical Working Group (TWG)/Secretariat emailed the ITB to a total of thirty-nine (39) known Drillers around the Philippines;

**WHEREAS**, the ITB was also posted to the agency's official Facebook account on December 5, 2023;

**WHEREAS**, on the deadline for the submission of the bid on December 18, 2023, 12:00 NN, no prospective bidder procured bidding documents and submitted a bid proposal per the record book (logbook) of the BAC TWG;

**WHEREAS**, on motion made by Engr. Noel A. Martinez, Jr., BAC Regular Member, which was duly seconded by Mr. Arturo M. Marco, BAC Vice Chairperson, the BAC declared the First Failure of Bidding for the project Supply of Labor and Materials for the Drilling of Pacol IV One (1) Test / Production Well at Zone 1, Km. 10, Pacol, Naga City (INFRA 2023-008);




