BAC RESOLUTION DECLARING FIRST FAILURE OF BIDDING FOR THE PROJECT SUPPLY, DELIVERY, INSTALLATION, TESTING, AND COMMISSIONING OF PUMP, ELECTRO-MECHANICAL EQUIPMENT, DISCHARGE LINE, ELECTRICAL EQUIPMENT, AND GENERATOR SET OF STA. LUCIA II PUMPING STATION (GOODS 2024-010) AND SUBSEQUENTLY RESCHEDULED REBIDDING FOR THE SAME AND RECOMMENDING APPROVAL BY THE HEAD OF PROCURING ENTITY (HOPE)/CHAIRMAN OF THE BOARD OF DIRECTORS OF METROPOLITAN NAGA WATER DISTRICT (MNWD)

WHEREAS, the Metropolitan Naga Water District (MNWD) Bids and Awards Committee (BAC), through its Secretariat, posted the Invitation to Bid (ITB) for the project Supply, Delivery, Installation, Testing, and Commissioning of Pump, Electro-Mechanical Equipment, Discharge Line, Electrical Equipment, and Generator Set of Sta. Lucia II Pumping Station (GOODS 2024-010) in the Philippine Government Electronic Procurement System (PhilGEPS), MNWD Bulletin Board, and MNWD Website on September 9 to 30, 2024, with an Approved Budget for the Contract (ABC) of THREE MILLION TWO HUNDRED THOUSAND PESOS (Php 3,200,000.00) ONLY. Delivery of the Goods is required within NINETY (90) CALENDAR DAYS. Pre-bid Conference was conducted last September 16, 2024;

WHEREAS, although five (5) prospective bidders attended during the Pre-Bid Conference, only one (1) bidder submitted bid documents during the Bid Opening of September 30, 2024, namely: (1) Armen Electro-Mech Sales and General Merchandise:

WHEREAS, during the Bid Opening on September 30, 2024, the BAC meticulously counterchecked the submitted documents of the bidders concerned against a checklist of required eligibility documents, as indicated in the ITB and the instruction to bidders, to ascertain the bidder's compliance with the requirements using a non-discretionary pass (/) or fail (x) criterion;

WHEREAS, during the Bid Evaluation Report on October 2, 2024, on the detailed examination of bids of the participating bidder, it offers varying brands for each component of the project, particularly in its Electro-Mechanical component, namely, Tormac for the Submersible Deep Well Pump and Motor, Grundfos for the Variable Frequency Drive, HPISD for Soft Starter; as well as in its Generator Set, which is of Hong Fu Brand for the Cummins Engine Generator; CRI Pipes for Riser Pipes; and locally manufactured brands for other project components;

NOW THEREFORE, we, the Members of the Bids and Award Committee, hereby, **RESOLVE**, as it is hereby, **RESOLVED**:

- To declare the First Failure of Bidding for the project Supply, Delivery, Installation, Testing, and Commissioning of Pump, Electro-Mechanical Equipment, Discharge Line, Electrical Equipment, and Generator Set of Sta. Lucia II Pumping Station (GOODS 2024-010) and subsequent rebidding; and,
- 2. To recommend approval by the Head of the Procuring Entity (HOPE)/Chairman of the Board of Directors of MNWD for the foregoing findings.
