**BAC RESOLUTION DECLARING FIRST FAILURE OF BIDDING FOR THE PROJECT FURNISHING OF LABOR AND MATERIALS FOR THE CONSTRUCTION OF STA. LUCIA II PUMPING STATION (INFRA 2024-002) AND SUBSEQUENTLY RESCHEDULED REBIDDING FOR THE SAME AND RECOMMENDING APPROVAL BY THE HEAD OF PROCURING ENTITY (HOPE)/CHAIRMAN OF THE BOARD OF DIRECTORS OF METROPOLITAN NAGA WATER DISTRICT (MNWD)**

**WHEREAS**, the Metropolitan Naga Water District (MNWD) Bids and Awards Committee (BAC), through its Secretariat, posted the Invitation to Bid (ITB) for the project **Furnishing of Labor and Materials for the Construction of Sta. Lucia II Pumping Station (INFRA 2024-002)** in the Philippine Government Electronic Procurement System (PhilGEPS), MNWD Bulletin Board, and MNWD Website on May 9, 2024, with an Approved Budget for the Contract (ABC) of **ONE MILLION TWO HUNDRED NINETEEN THOUSAND TWENTY-TWO PESOS AND 14/100 (Php 1,219,022.14)**. Completion of the Works is required within **NINETY (90) CALENDAR DAYS**. A Pre-bid Conference was conducted last May 6, 2024;

**WHEREAS**, although no prospective bidder attended during the Pre-Bid Conference last May 16, 2024, two (2) bidders submitted bid documents during the Bid Opening of May 28, 2024, namely: (1) **Gian Alyanna Construction and Supply Corporation**; and (2) **Mikad Construction and Engineering Services**;

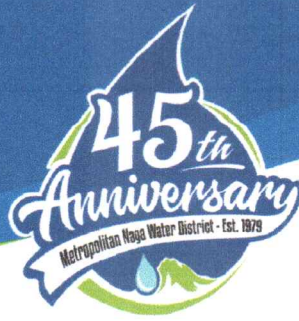
**WHEREAS**, both bidders were declared ineligible to bid during the Bid Opening due to the following reasons:

1. **Gian Alyanna Construction and Supply Corporation** for its **failure to submit the required Omnibus Sworn Statement** under Section 25.2 (b) of 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184; and
2. **Mikad Construction and Engineering Services** for submitting an **expired PhilGEPS Registration** with an expiration date of May 13, 2024, as required in Section 25.2 (b) and following Section 8.5.2 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 for the procurement of goods and infrastructure projects, respectively

**NOW THEREFORE**, we, the Members of the Bids and Award Committee, hereby, **RESOLVE**, as it is hereby, **RESOLVED**:

1. To declare the First Failure of Bidding for the project Furnishing of Labor and Materials for the Construction of Sta. Lucia II Pumping Station (INFRA 2024-002) and subsequent rebidding; and,
2. To recommend for approval by the Head of the Procuring Entity (HOPE)/Chairman of the Board of Directors of MNWD the foregoing findings.

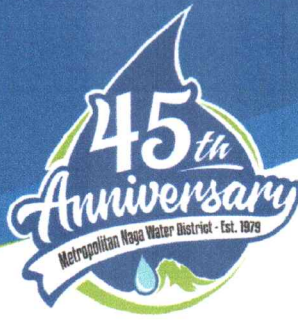


