1. The units must be all brand new and manufactured conforming to IEEE/ANSI Standards.
2. The units shall be oil immersed, self-cooled double bushing, 60 HZ Pri: 7620/13200V, Sec: 230/460V, BIL 95, Turns ratio tolerance +/- 1% with external tap changer.
3. The units shall be furnished with no load manual winding taps at 2-1/2 % above and below normal voltage.
4. The core and winding of transformers shall be designed and constructed to give the minimum core loss and shall provide the least percentage ratio of the exciting current to full load ampere rating as required by Electric Cooperative / NEA.
5. The units should passed the required field testing of Casureco II.
6. The supplier shall guarantee that the units shall be free from all defective workmanship and material for a period of one (1) year after final acceptance of the project. Any defect appearing within the aforesaid period shall be remedied by the supplier at his own expense including testing fees.

8. The supplier must submit a copy of Manufacturers Transformers Test Result of the said units upon completion.
9. The supplier must submit a copy of Casureco II Transformer Test result upon completion.
10. The supplier must submit a clear copy of the nameplates of the distribution transformer.
11. The units must conformed with the standard color ANSI 70 gray.
