The **METROPOLITAN NAGA WATER DISTRICT**, through its approved Corporate Budget, intends to apply the sum of **THREE MILLION EIGHTY NINE THOUSAND TWO HUNDRED TEN AND 96/100 (Php 3,089,210.96)** only, being the Approved Budget for the Contract (ABC) to payments under the contract for the **FURNISHING OF LABOR AND MATERIALS FOR THE INSTALLATION OF PIPE RELOCATION PROJECT AT CORNER J. HERNANDEZ / ARANA ST. TO STA. CRUZ BRGY. HALL, BRGY. STA. CRUZ; FELIX PLAZO ST., BRGY. IGUALDAD TO BRGY. SABANG; AND ABELLA ROAD TO ABELLA BRGY. HALL, BRGY. ABELLA, NAGA CITY** CONTRACT REFERENCE NO. **INFRA 2017-012**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The MNWD now invites bids for the **FURNISHING OF LABOR AND MATERIALS FOR THE INSTALLATION OF PIPE RELOCATION PROJECT AT CORNER J. HERNANDEZ / ARANA ST. TO STA. CRUZ BRGY. HALL, BRGY. STA. CRUZ; FELIX PLAZO ST., BRGY. IGUALDAD TO BRGY. SABANG; AND ABELLA ROAD TO ABELLA BRGY. HALL, BRGY. ABELLA, NAGA CITY**. Completion of the Works is required within **Two Hundred Fifty Five (255) Calendar Days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".  
  
Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives and partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from the MNWD and inspect the Bidding Documents at the address given below starting from 8:00 AM – 12:00 NN and 1:00 PM – 5:00 PM.
5. A complete set of Bidding Documents may be acquired by Interested Bidders starting on **WEDNESDAY, DECEMBER 20 to JANUARY 9, 2018**, from the

address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **FIVE THOUSAND PESOS (Php 5,000.00) only**.

6. The MNWD will hold a Pre-Bid Conference on **DECEMBER 28, 2017 at 1:30 pm** at 2<sup>nd</sup> Floor, Board Room, MNWD Building, 40 J. Miranda Avenue, Naga City, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **JANUARY 9, 2018; 1:30 pm**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.  
  
Bid Opening shall be open on **JANUARY 9, 2018; 1:30 pm**. at 2<sup>nd</sup> Floor, Board Room, MNWD Building, 40 J. Miranda Avenue, Naga City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
8. The MNWD reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
