

**Invitation to Bid for
FURNISHING OF LABOR AND MATERIALS FOR
THE INSTALLATION OF DISTRIBUTION LINE AT
ZONE 6, COPRADIA, BARANGAY SAN FELIPE,
NAGA CITY**

1. The **METROPOLITAN NAGA WATER DISTRICT (MNWD)** through its approved Corporate Budget, intend to apply the sum of **FOUR HUNDRED TWELVE THOUSAND NINE HUNDRED SEVEN PESOS AND 21/100 (Php 412,907.21)** only being the Approved Budget for the Contract (ABC) to payments under the contract for the **FURNISHING OF LABOR AND MATERIALS FOR THE INSTALLATION OF DISTRIBUTION LINE AT ZONE 6, COPRADIA, BARANGAY SAN FELIPE, NAGA CITY PROJECT NO. INFRA 2020-001**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The MNWD now invites bids for **FURNISHING OF LABOR AND MATERIALS FOR THE INSTALLATION OF DISTRIBUTION LINE AT ZONE 6, COPRADIA, BARANGAY SAN FELIPE, NAGA CITY**. Completion of the Works is required **ONE HUNDRED TWENTY DAYS (120) CALENDAR DAYS**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organization with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from **MNWD** and inspect the Bidding Documents at the address given below from 8:00 AM – 12:00 NN AND 1:00 PM – 5:00PM
5. A complete set of Bidding Documents may be acquired by interested bidders on **FRIDAY, JANUARY 24 to FEBRUARY 12, 2020** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **FIVE HUNDRED PESOS (Php 500.00)** only

BID OPENING shall be on **FEBRUARY 12, 2020 at 1:30 PM** at 2nd Floor, Conference Room, MNWD Building, 40 J. Miranda Avenue, Naga City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The MNWD reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
