

INVITATION TO BID FOR SUPPLY AND DELIVERY OF WATER METERS 1/2" Ø (BRAND NEW, CLASS C) VOLUMETRIC ROTARY- PISTON TYPE CONNECTORS FOR REPLACEMENT OF AGEING WATER METERS

1. The **METROPOLITAN NAGA WATER DISTRICT (MNWD)** through its approved Corporate Budget, intends to apply the sum of **ONE MILLION TWO HUNDRED TEN THOUSAND PESOS (Php 1,210,000.00)** Only, being the Approved Budget for the Contract (ABC) to payments under the contract for the **SUPPLY AND DELIVERY OF WATER METERS 1/2" Ø (BRAND NEW, CLASS C) VOLUMETRIC ROTARY-PISTON TYPE CONNECTORS FOR REPLACEMENT OF AGEING WATER METERS, PROJECT NO. GOODS 2020-007**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *MNWD* now invites bids for the above Procurement Project. Delivery of the Goods is required by **THIRTY (30) CALENDAR DAYS**. Bidders should have completed, within the last two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Prospective Bidders may obtain further information from *MNWD* and inspect the Bidding Documents at the address given below starting from 8:00 AM – 12:00 NN and 1:00 PM - 5:00 PM.
5. A complete set of Bidding Documents may be acquired by interested Bidders starting on **TUESDAY, OCTOBER 30 TO NOVEMBER 18, 2020** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **FIVE THOUSAND PESOS (Php 5,000.00)** only.

The *MNWD* shall allow the bidder to present its proof of payment for the fees through *MNWD* Cashier, cash/check via courier, or a copy of bank deposit slip emailed to the *MNWD* BAC as indicated below.

6. The *MNWD* will hold a **Pre-Bid Conference on November 6, 2020, 1:30 PM** at 3rd Floor, Multi-Purpose Hall, *MNWD* Building, 40 J. Miranda Avenue, Naga City, and/or through **Zoom Video Conference** which shall be open to prospective bidders.



For those who are interested to join the video conference, you are hereby advised to submit your letter of intent one (1) day before the scheduled Pre-Bid Conference, indicating the e-mail address, wherein the Zoom Video Conference I.D. and password will be sent. 

The *MNWD* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
